- b) The Trustees shall invest the properties and moneys of the Trust in such manner as prescribed under Sec.11 of the Income Tax Act 1961 and other Statutory Laws.
- c) The Board of Trustees shall meet as often as necessary and their proceedings shall be recorded regularly in the Minutes Book to be retained for the purpose. In any resolution passed touching the administration of Trust, the opinion of the majority shall prevail. In case there being equality of votes, the Chairman of the meeting has casting vote for purpose of deciding the issue.
- d) The Trustees may open and operate current or deposit or other accounts in the name and for the Trust with any schedule Bank of Banks. The Managing Trustee shall be authorised to have the power to operate such Bank Accounts.
- e) The Board may by resolution extend the activities of the Trust or undertake any activity in furtherance of the main objects of the Trust.
